At Tollgate Primary School we run a mastery curriculum. This means that all curriculum areas are a progressive model where pupils build on previous learning through their knowledge and application of clear and concise composite goals. Pupils know more and remember more through rehearsal, which leads to a deep and secure knowledge of the key components.

We at Tollgate Primary School believe 'music is a universal language that embodies one of the highest forms of creativity. A high quality music education should engage and inspire pupils to develop a love of music and their talent as musicians, and so increase their self-confidence, creativity and sense of achievement. As pupils progress, they should develop a critical engagement with music, allowing them to compose, and to listen with discrimination to the best in the musical canon.' (The National Curriculum in England Framework Document (DfE) 2014)

We as a school community have a commitment to promote equality. Therefore, an equality impact assessment has been undertaken and we believe this policy is in line with the Equality Act 2010.

## Aims

- To ensure that all pupils perform listen to, review and evaluate music across a range of historical periods, genres, styles and traditions, including the works of great musicians and composers.
- To ensure that all pupils learn to sing and to use their voices, to create and compose music on their own and with others, have the opportunity to learn a musical instrument, use technology appropriately and have the opportunity to progress to the next level of musical excellence.

- To ensure that all pupils understand and explore how music is created, produced and communicated, including through the inter-related dimensions: pitch, duration, dynamics, tempo, timbre, texture, structure and appropriate musical notations;
- To promote the teaching of numeracy and literacy within all subjects.
- To share good practice within the school.
- To work with other schools to share good practice in order to improve this policy.

#### **Foundation Stage**

We teach Music in the Nursery and Reception classes as an integral part of the topic work covered during the year. As these classes are a part of the Foundation Stage of the National Curriculum, we relate the Musical aspects of the children's work to the objectives set out in the 'Statuary Framework for Early Years Foundation Stage 2021' which underpins the curriculum planning for children from birth to five. around the world. Music runs through all the seven areas of learning and is integral to the overall development of children.

#### **Key Stage One**

- use their voices expressively and creatively by singing songs and speaking chants and rhymes
  play tuned and untuned instruments musically
- listen with concentration and understanding to a range of high-quality live and recorded music
- experiment with, create, select and combine sounds using the interrelated dimensions of music

## **Key Stage Two**

- play and perform in solo and ensemble contexts, using their voices and playing musical instruments with increasing accuracy, fluency, control and expression
- improvise and compose music for a range of purposes using the interrelated dimensions of music
- listen with attention to detail and recall sounds with increasing aural memory
- use and understand staff and other musical notations
- appreciate and understand a wide range of high-quality live and recorded music drawn from different traditions and from great composers and musicians
- develop an understanding of the history of music

#### Roles and Responsibility for the Policy

This policy is designed to enable teachers to provide high quality teaching and learning for all children in Music, enhancing their educational experience of Music. The policy will lay out the guidance for the delivery and teaching of Music for all staff engaging with the subject.

The Headteacher and the Senior Leadership Team will:

- Ensure all school personnel are aware of and comply with this policy;
- Work closely with the School Leader for Music and the link governor;
- Ensure compliance with the legal requirements of the National Curriculum;

- Encourage parents to take an active role in Music curriculum development;

- Monitor the effectiveness of this policy by;

- Planning checks
- Engage with the pupil voice of the school
- Annually report to the Governing Body on the success and development of this policy

- Work closely with the Headteacher and the nominated governor;
- Be accountable for standards in Music;
- Monitor standards by;
- Auditing whole school resources for Music
- Review the Charanga teaching tool
- Monitoring teachers planning
- Lesson observations
  - Observe children's musical development and competence
- Engaging with pupil voice
- Conduct learning walks
- Ensure continuity and progression throughout the school;
- Devise a subject improvement plan;
- Provide guidance and support to all staff engaging with the teaching of Music;
- Provide training for all staff on induction and when the need arises regarding Music;
- Attend appropriate and relevant INSET and external CPD;
- Keep up to date with new developments;
- Undertake an annual audit and stock take of resources;
- Purchase new resources when required and in preparation for the new academic year;
- Manage the subject budget effectively; Undertake risk assessments when required; Review and monitor.

#### The Link Governor will:

## **Teaching and Learning Style**

At Tollgate Primary School we make music an enjoyable learning experience. We encourage children to participate in a variety of musical experiences through which we aim to build up the confidence of all children. Singing lies at the heart of good music teaching. Our teaching focuses on developing the children's ability to sing in tune and with other people. Through singing songs, children learn about the structure and organisation of music. We teach them to listen and to appreciate different forms of music. As children get older, we expect them to maintain their concentration for longer and to listen to more extended pieces of music. Children develop descriptive skills in music lessons when learning about how music can represent feelings and emotions. We teach them the disciplined skills of recognising pulse and pitch. We often teach these together. We also teach children how to work with others to make music and how individuals combine together to make sounds. We also teach them musical notation and how to compose music.

We recognise that there are children of widely different musical abilities in all classes, so we provide suitable learning opportunities for all children by matching the challenge of the task to the ability of the child. We achieve this in a variety of ways by:

- setting common tasks which are open-ended and can have a variety of responses;
- setting tasks of increasing difficulty (not all children complete all tasks);
- grouping children by ability in the room and setting different tasks to each ability group;
- providing resources of different complexity depending on the ability of the child;
- using classroom assistants to support the work of individuals or groups of children

We use a variety of teaching and learning styles in order to develop children's knowledge, skills and understanding. Some aspects of the Music programme of study are delivered through the Topic Curriculum; whereby our pupils access areas of the Music National Curriculum through themed topics of study. The school has also adopted a music scheme of work developed by Charanga. The music curriculum is also delivered through our weekly singing assemblies for key stage one and two and both small group and whole class instrumental lessons. (Due to current COVID-19 restrictions, unfortunately these assemblies are not permitted. These will be resumed when the government guidelines change and it is deemed safe to do so).

At Tollgate Primary School we also understand the value of extended learning through educational trips, visits and experts visiting our school.

## Additional music teaching

At Tollgate Primary School, all children in Y3 and Y4 receive whole class instrumental lessons with a specialist music teacher from Newham Music Trust. Currently, children in Y3 and Y4 receive engaging and practical instrumental

lessons on the Ukulele and the Melodica. This enriches the children's experience of the music curriculum by receiving excellent music tuition first-hand from professional instrumentalists.

In addition, Tollgate Primary School work in partnership with Newham Music Trust and finance a further 40-50 children across key stage 2 to receive additional small group instrumental lessons with specialist peripatetic tutors. Currently, children across Key Stage 2 are receiving small group lessons on the violin, cello, flute, clarinet, trumpet, french horn and trombone.

#### **Curriculum Planning and Organisation**

Our school uses the National Curriculum programme of study for music as the basis for its curriculum planning. We have adapted the scheme so that the topics that the children study in music build upon prior learning. While there are opportunities for children of all abilities to develop their skills and knowledge in each teaching unit, the planned progression built into the scheme of work means that the children are increasingly challenged as they move through the school.

We carry out the curriculum planning in music in three phases (long-term, medium-term and short-term). The longterm plan maps the music topics studied in each term during the key stage. The music subject leader works this out in conjunction with teaching colleagues in each year group. Sometimes the children study music topics in conjunction with other subjects, particularly at Key Stage 1. Through this programme of study we teach the knowledge, skills and understanding set out in the National Curriculum.

The medium-term plans, which we have adopted from the national Curriculum, give details of each unit of work for each term. The music subject leader is responsible for keeping and reviewing these plans.

The subject leader writes the daily lesson plans, which list the specific learning objectives of each lesson. The class subject lead is responsible for keeping these individual plans, and the class teacher and music subject leader often discuss them on an informal basis.

Our music planning is geared to three aspects of progress:

- increasing breadth and range of musical experiences;
- increasing challenge and difficulty in musical activities;
- increasing confidence, sensitivity and creativity in the children's music making.

## **Foundation Stage**

We teach music in our reception classes as an integral part of the topic work covered during the year. As the reception class is part of the Foundation Stage of the National Curriculum, we relate the musical aspects of the children's work to the objectives set out in the Early Learning Goals (ELGs) which underpin the curriculum planning for children aged three to five. Music contributes to a child's personal and social development. Counting songs foster a child's mathematical ability and songs from different cultures increase a child's knowledge and understanding of the world.

Teachers collaborate on the planning of the subject to ensure parity in provision and to share expertise. Curriculum planning is managed in three phases namely:

## Long Term Planning

- Details what is to be taught over the year
- Provides teaching guidelines and overall objectives for each year group for the whole year in-line with the scheme of work provided (Charanga)

#### Medium Term Planning

- Organises the subject into termly or half-termly sections using the scheme of work provided (Charanga)
- Is more detailed and the objectives are more specific in nature
- Is developed by the teachers, who respond to the needs of their pupils
- Ensures a balanced curriculum is covered across each term

## **Short Term Planning**

- Plans lessons in detail with specific class objectives reflecting the needs of all children within the class

Currently, children across the school learn to play the ukulele, flutophone, flute and clarinet through ECaM. Additional children in Key Stage 2 receive further instrumental lessons financed by Tollgate Primary School through Newham Music Trust. Class music teaching also provides an opportunity for the children to engage with a range of tuned and un-tuned instruments.

Singing is taught to all children on a Thursday for 30minutes for both Key Stage 1 and 2(as stated previously, due to Covid-19 these assemblies are not permitted at this time). The children engage with a range of different musical material from across the world, exploring both Western and non-western songs, languages and different cultural styles. All children engage with the singing provision and work towards a concert at the end of each term. The children perform their songs alongside a professional band, which enriches their experience of performing in a live setting. Teaching staff should take an active role throughout singing, encouraging all children to fully participate and enjoy the experience.

#### **Links with Computing**

The use of information and communication technology will be used to broaden and develop the way children engage and consider musical education. We currently use Charanga as a visual online platform for children. We also use a programme called Amped Studio in some year groups. 'Amped Studio is a modern web based music studio and production environment. With instant access to virtual instruments, effects, loops and easy to use tools to make music right in your browser.'

#### Inclusion

At our school we teach music to all children, whatever their ability. Music forms part of the school curriculum policy to provide a broad and balanced education to all children. Through our music teaching we provide learning opportunities that enable all pupils to make progress. We do this by setting suitable

learning challenges and responding to each child's different needs. Assessment against the National Curriculum allows us to consider each child's attainment and progress against expected standards. When progress falls significantly outside the expected range, the child may have special educational needs. Our assessment process looks at a range of factors – classroom organisation, teaching materials, teaching style, adaption– so that we can take some additional or different action to enable the child to learn more effectively. This ensures that our teaching is matched to the child's needs. Intervention through SEN Support and EHC plans will lead to the creation of an Individual Education Plan (IEP) for children with special educational needs. The IEP may include, as appropriate, specific targets relating to music. We enable pupils to have access to the full range of activities involved in learning music. Where children are to participate in activities outside the classroom, for example, a visit to a local park to count insects we would carry out a risk assessment prior to the activity, to ensure that the activity is safe and appropriate for all pupils. As well as this we have a tailored curriculum aimed our SEN children who do not meet pre key stage standards.

## **Achieving Mastery**

At Tollgate Primary School we run a mastery curriculum. This means that all curriculum areas are designed as a progressive model where pupils build on previous learning through their knowledge and application of clear and concise composite goals. Pupils know more and remember more through rehearsal, which leads to a deep and secure knowledge of the key components. At Tollgate we strive to deliver exceptional lessons where all children are expected to meet the learning objective and achieve mastery. We recognise the fact that there are children of widely different artistic abilities in all classes and we provide suitable pathways for all children to achieve the learning objective. These pathways include:

- Adaption
- Support
- Deepening Understanding
- Lowest 20% Toolkit

<u>Adaption:</u> is the altering or changing of the task so it is accessible for SEND children. The adaption of task should take into consideration the learning objective, stage of learning the child is at and barriers to learning a child may encounter

<u>Support</u>: Support is any resource which may assist a pupil in achieving the learning objective. This may take the form of assistance from an adult (teacher or teacher or assistant), a modelled example of what is needed to succeed in the lesson or any other pictorial or concrete resource that can help the children achieve mastery

<u>Deepening Understanding:</u> Children who have met the objective of the lesson can deepen their understanding of the component or composite goal by completing a task that encourages a child to apply or explain the knowledge and skills they have acquired.

<u>Lowest 20% toolkit:</u> These are strategies aimed at the lowest 20% children in your class. They are strategies to enable children working within the lowest 20% to access and meet the demands of our mastery curriculum. These strategies include; Live Modelling, Support or scaffold, variated questions,

setting the 'Bigger Picture', key vocabulary, 1:1 support, 1:2 Support and carefully planned independent learning time.

#### **Special Educational Needs**

At Tollgate Primary School we teach music to all children, whatever their ability. Music forms part of the school curriculum policy to provide a broad and balanced education to all children. Through our music teaching we provide learning opportunities that enable all pupils to make progress. We do this by setting suitable learning challenges and responding to each child's different needs. Assessment against the National Curriculum allows us to consider each child's attainment and progress against expected levels.

When progress falls significantly outside the expected range, the child may have special educational needs. Our assessment process looks at a range of factors – classroom organisation, teaching materials, teaching style, variation— so that we can take some additional or different action to enable the child to learn more effectively. This ensures that our teaching is matched to the child's needs.

Intervention through SEN Support and EHC plans will lead to the creation of an Individual Education Plan (IEP) for children with special educational needs. The IEP may include, as appropriate, specific targets relating to music.

We enable pupils to have access to the full range of activities involved in learning music. Where children are to participate in activities outside the classroom, for example, a musical festival at another school, we carry out a risk assessment prior to the activity, to ensure that the activity is safe and appropriate for all pupils.

We want pupils with identified special educational needs to have full access to all subjects of the National Curriculum with teachers planning lessons that have no barriers to pupils achieving and with appropriate targets relating to the subject.

Tollgate Primary School have a HCPC Registered Music Therapist on site who takes children from the ASD provision for 1:1 or small group session on a weekly basis. The Music Therapist tailors their approach to meet the needs of each individual child and works to build a therapeutic relationship in order to foster interaction through live improvised music and structured musical activities. Music Therapy may help children with ASD to improve their skills in important areas such as:

- Social interaction and communication
- Self-expression
- Emotional support
- Cognitive development
- Self-esteem

In addition, the Music Therapist works closely with the deputy safeguarding leads, SENCo, family centre staff and class teachers to identify mainstream children who could benefit from a Music therapy intervention.

Sessions take place individually and the therapist works to help the child find a safe place through the music to explore their feelings and to learn strategies for managing their own behaviour. Music Therapy is used to support their social and emotional development and in turn, their progression in the class.

## **Assessment for Learning**

Teachers assess children's work in music by making informal judgements as they observe them during lessons. On completion of a piece of work, the teacher marks the work and comments as necessary. The music subject leader keeps samples of children's work in a portfolio, which s/he uses to demonstrate the expected level of achievement in music for each age group in the school.

Within upper Key Stage 2, children who receive small group lessons from Newham Music Trust have the opportunity to sit their grade 1 exam through the Associated Board of the Royal Schools of Music. This is a huge achievement and if successful, the pupils are awarded a graded examination certification with pass, merit or distinction.

#### Teachers will:

- Carry out continuous and ongoing teacher assessment;
- Carry out medium-term teacher assessment to measure progress against key objectives in the Music curriculum;
- Carry out longer-term teacher assessment to assess musical development against the Music curriculum and the wider school.
- Learning walks

#### **Monitoring & Review of the Subject**

Monitoring of standards of children's work and the quality of teaching is the responsibility of the School Leader for Music supported by the Headteacher and the SLT.

Standards will be monitored by:

- •
- Subject observations
- Learning walks
- Pupil discussions
- Engagement with planning

#### Contribution of the Subject to other Areas of the Curriculum

Music can be linked to most curriculum subjects.

## Resources

The school has a range of resources to support the teaching of Music throughout all year groups. Resources are upgraded and replenished when the need arises. An annual stock take and audit is undertaken by the School Leader for Music in the summer term in preparation for the next academic year.

## The school choir/orchestra and musical events

We believe that music enriches peoples' lives and so we wish to involve as many children as possible in musical activities. We have a school choir, which all children are encouraged to join. The choir meets on a weekly basis and, although its primary aim is to enable children to enjoy singing together, it also performs in public on a number of occasions throughout the year, for example at the Christmas carol concert.

Additionally, Tollgate has a Key Stage 2 orchestra. The orchestra rehearses every Friday afternoon and consists of 40-50 children playing instruments such as the violin, cello, flute, clarinet, trumpet, french horn, trombone and the drum kit. The orchestra perform a diverse range of pieces throughout the academic year both within the school and the wider community. It is the opinion of Tollgate Primary School that regularly rehearsing and performing in the orchestra helps develop the children's music skills and creates a supportive environment where the children work together and encourage each other to develop musical and creatively.

As well as this children have the opportunity in Key Stage 1 to investigate Gamelan, a traditional Indonesian instrument consisting of metallophones and dongs. This culminates in a traditional puppet show which children perform for the school and wider community.

To mark the end of our Year six's time at Tollgate, all children in Year Six participate in an end of year musical. This is facilitated by Brick Lane Studio, an independent studio ran by actors and performers. This normally has a variety of genres and changes yearly.

## **Raising Awareness of this Policy**

We will raise awareness of this policy via:

## **Training**

Tollgate Primary School will provide opportunities for all employees to have access to the information, instruction, supervision and training required to enable them to discharge their responsibilities.
